## Thailand

With a whopping 59 fee earners, 38 of which are lawyers and 21 trade mark and patent specialists and paralegals, Tilleke & Gibbins continues to be the only firm in Thailand with a Tier one ranking across the board.

A significant achievement this past year saw Srila Thongklang and Nuttaphol Arammuang defend Swiss company Jet Aviation Management in a trade mark opposition brought by ConocoPhillips. The Supreme Court ruled in favour of the client, whose mark was allowed to be registered and commercialised.

In another accomplishment, Alan Adcock and his team obtained a rarely granted Anton Piller Order from the IP & IT Court on behalf of a manufacturer of magnetic powder. The order allowed the team to seize evidence proving trade secret infringement against the alleged infringer. The case is at trial.

## Vietnam

Tilleke & Gibbins has a strong international reputation in anti-counterfeiting, strategic filing advice, and commercial IP work. The firm's practice in Vietnam is led by the widely respected Thomas Treutler and Nguyen Thi Phi Nga. The firm has been handling complex patent infringement work on behalf of a leading European agrochemical producer against three local pesticides producers, resulting in one of the first assessment opinions issued on a complex patent case in Vietnam. Nguyen successfully acted for LEO Pharmaceutical Products on a number of oppositions to trade mark applications that were found to be confusingly similar to Fucidin, opening up a broader interpretation of what might be considered confusingly similar in Vietnam.

Treutler and Nguyen represented European apparel maker Lacoste in a number of actions in Vietnam in 2010. In particular, the authorities imposed a \$10,000 fine on local counterfeiters, one of the largest fines ever levied in Vietnam for an IP law violation. The firm also boasts a client list that includes Honda Motor, Bayer CropScience, Boehringer Ingelheim and Shiseido.
